

Slippery Rock Township Supervisors

Minutes for: 10/26/20

Chairman, Paul Dickey called the meeting to order at 3:00 p.m. In attendance were Supervisors John Hines and Terry Doerr along with Mike Hnath, Solicitor, Dave Neill, Engineer, and six members of the public.

John Hines made a motion to approve the October 12, 2020 minutes, approve and pay the bills, and approve the financial report. Terry Doerr seconded and the motion carried unanimously.

Open Comment(s)

Samantha Lawrence and April Claus, SRU Macoskey Center, addressed the board with information concerning the center and a grant application to improve the trails and wet lands. They are asking for the township to send a letter of support for the grant. A short discussion ensued, the township will send a letter of support.

John Hines made a motion to send a letter of support for the Macoskey Center grant to improve the trails and wetlands. Terry Doerr seconded and the motion carried unanimously.

Chris Coleman, addressed the board with concerns of the special exception for the asphalt plant at the intersection of Stoughton and New Castle Roads. A short discussion ensued, Mike Hnath explained that this public hearing will be handled by the Zoning Hearing Board with a tentative date of Tuesday, November 24, 2020, pending a quorum. After the public hearing, the land owner will then go through the land development process with the Slippery Rock Planning Commission. SRPC will review the plan and any conditions and/or requirements recommended by the Zoning Hearing Board. Then the plan will be forwarded to the Supervisors for review.

Engineer Report

Dave Neill reported the following to the board:

1. Pavilion project – proposed timeline
2. Maintenance Building – restroom options

Other Business

Cares Act – round 2 of funding – UV Light installation cost – received a bid from B. L. Boyer

John Hines made a motion to approve the installation of the UV Lights for the ventilation system in the amount of \$6,750.00 with B. L. Boyer. Terry Doerr seconded and the motion carried unanimously.

CDBG-CV – rent/mortgage/utilizes assistance for residents – Butler County will be putting out a press release in the near future.

PLGIT – Prime account / Act 10 of 2016, a short discussion ensued.

Paul Dickey made a motion to approve the PLGIT prime account. Terry Doerr seconded and the motion carried unanimously.

2021 Budget – additions/changes, a short discussion ensued, Paul wanted to add a \$5,000.00 expense for QuickBooks.

25 years of service – additional vacation, a short discussion ensued.

Terry Doerr made a motion to approve an additional week of vacation, for a total of six-weeks, for Randy Long for twenty-five years of service for the duration of his employment. John Hines seconded and the motion carried unanimously.

Macoskey Center – grant, this was handled under open comment.

Appoint ZHB alternate - James Anderson and/or Daniel Hartzell, a short discussion ensued.

Terry Doerr made a motion to appoint James Anderson and Daniel Hartzell to the Zoning Hearing Board as alternates. John Hines seconded and the motion carried unanimously.

Arrowhead Drive – closure for trick-or-treat. A short discussion ensued.

Paul Dickey made a motion to approve the closure of Arrowhead Drive from Miller Road to the start of Crossbow Lanes on October 31, 2020 from 5:30 p.m. until 8:30 p.m. for trick-or-treat. The road crew will provide the road close signs and then retrieve the road close signs. The road close signs are to be manned by several of the residents in the development to allow for any emergency vehicles or necessary traffic to be permitted through. John Hines seconded and the motion carried unanimously.

Paul Dickey asked if there was any further or additional business. None


Terry Doerr made a motion to adjourn the meeting at 4:09 p.m. John Hines seconded and the motion carried unanimously.


