- <u>Junk Vehicles</u> Mike Hnath, solicitor had suggested the PC discuss this. Mike has conveyed to the SRPC that the Township has received several recent complaints in regards to junk vehicles and asked the SRPC to review existing ordinances that would address this issue and consider amendments if warranted. Discussion ensued with the commission electing to review the township's existing ordinances along with a sample provided by Mike at the next scheduled meeting.
- Annual SRPC Report. The report submitted for review. Two minor corrections were noted.

Terry Doerr made a motion to approve the 2020 Annual SRPC Report contingent on the two items being revised and forward to the Supervisors at their next scheduled meeting. Mary Purdy seconded and the motion carried unanimously.
