Ordinance Chapter 18 Sewers and Sewage Disposal – Rick Grossman-Chapter 18-draft for review. Rick presented the commission with a draft for discussion titled "Slippery Rock Township On-Lot Sewage and Holding Tank Regulations and Specifications" plus DEP 10 Acre Permit Exemption Documentation Form. Rick informed the commission that the original Chapter 18 gave the Township the power to write specifications; which would be adopted by resolution. Rick also reviewed this with the solicitor who concurs that new regulations can be adopted by resolution, stating that that would essentially be adopting a rule/regulation that simply clarifies the applicability of the Ordinance. Discussion continued with Rick's input that this would address holding tanks and 10 acre exemption specifications. The commission is to review the hand-out and continue discussion at their next regular scheduled meeting in July plus Rick will forward a copy to the Township SEO for comments.
