# Slippery Rock Township Supervisors Minutes for: September 30, 2019

Chairman Paul Dickey called the meeting to order at 3:23 p.m. In attendance were Supervisors John Hines and Terry Doerr along with Wil White, solicitor, and Dave Neill, engineer, and four members of the public.

John Hines made a motion to approve the minutes from September 9, 2019, approve and pay the bills and approve the financial reports. Terry Doerr seconded and the motion carried unanimously.

Ordinance #2019-2 - increase weight limit in the C-1 Commercial Zone only from 10T to 20T.

John Hines made a motion to adopt Ordinance #2 of 2019 to increase the weight limit from 10T to 20T in the C-1 Commercial Zone for Arrowhead Drive and Woodbridge Drive only. Terry Doerr seconded and the motion carried unanimously.

<u>Ordinance #2019-3</u> – decrease speed limits on several township roadways. A short discussion ensued with the outcome to table until Wil completes the ordinance.

Paul Dickey made a motion to table Ordinance #3 of 2019 speed reduction on several township roadways. Terry Doerr seconded and the motion carried unanimously.

## **Engineer Report - David Neill**

Dave Neill reported the following to the board:

Sanderson Road – CDBG project, design is underway and should be put out to bid this winter for the start of the project in the spring of 2020.

Sewer Connection – work has been completed with restoration and close out documents to be finalized. The work was to be completed by September 15, 2019. There was no request from Mortimer for a time extension. The liquidated damages are \$1,000.00 per day.

Kiester Road Drainage Project – drainage project is completed the final invoice has been submitted in the amount of \$4,871.50.

Paul Dickey made a motion to pay Terra Works in the amount of \$4,871.50 for the final payment for the Kiester Road drainage project. Terry Doerr seconded and the motion carried unanimously.

**Kiester Road Paving - completed by Shields Paving.** 

John Hines made a motion to approve and pay Shields Paving in the amount of \$157,790.91 for the Kiester Road paving project. Terry Doerr seconded and the motion carried unanimously.
