Zoning/Planning Report - Mark Lazzari

- 1. <u>The Solar and Wind Energy Zoning Amendments</u> have been provided to SRPC and TWP solicitor for their final review and consideration. Solicitor had minor revision and will review and finalize and move forward by scheduling a public hearing.
- 2. <u>Junkyard Ordinance</u> SRPC made a motion to recommend approval contingent on minor revisions and forward to the Supervisors for consideration along with the solicitor coordinating a public hearing.
- 3. <u>Small Cell Wireless Facilities</u> Mark gave a brief summary of the facilities and he noted that the SRPC asked Mark to develop some language for a draft ordinance to consider. This will be upcoming.
- 4. <u>False Fire Alarms</u>. Mark reported that Ryan Hanchosky, SR Vol Fire Dept. Fire Chief, attended the SRPC meeting earlier this evening. Mark summarized Ryan's comments and concerns as discussed with the SRPC. Mark noted that the TWP solicitor will be contacted for guidance on the TWP liability and what action can be taken. Mark also noted that the following are actions as requested by the SRPC:
 - a. TWP to get a report from the SR Fire Company to notify and charge fees for any false fire alarms in accordance with the TWP ordinance.
 - b. TWP to get expense documents for fire alarm call-outs to possibly use to adjust fine amounts per TWP ordinance.
