Chairman, Paul Dickey, called the meeting to order at 3:04 p.m. In attendance were Supervisors John Hines and Terry Doerr. Mike Hnath, Solicitor, attended in person. Zoning/Planning Report – Mark Lazzari

Mark Lazzari - reported to the board that the Suorsa Subdivision is on hold until the owner submits information to the SEO concerning the non-building waiver.

PSATS Seminar - American Recovery Plan seminar Karen to attend on July 20th in Erie, a short discussion ensued.

Crestview & McCandless Roads - ditch and maintenance issue, a short discussion ensued with the outcome being that on Crestview Road several residents will need to move their mailboxes out of the ditch line. McCandless Road issues will be handled with the rehabilitation, that will be occurring in the next year, with CDBG funding.

Other Business

CDBG Monies for Park Project revision to reallocations

B. C. Park grant \$7,500.00 (Twp. match is \$2,500.00 can use CDBG money)

Revise allocations from \$42,196.95 to \$34,696.95

\$54,894.05 will remain for housing rehab using 2020 CDBG funds

CDBG Picnic Pavilion – Butler County awarded the bid to Lee Michael Industries, Inc, New Castle, PA in the amount of \$97,468.00 once all of the paperwork is received a pre-construction meeting and notice to proceed date will be set.

Paul Dickey made a motion to revise the CDBG allocations for the picnic pavilion project from \$42,196.95 to \$34,696.95 and to approve the spending of the \$7,500.00 Butler County Park Grant with matching funding of \$2,500.00 for the picnic pavilion project and to approve the bid in the amount of \$97,468.00 to Lee Michael Industries, Inc., New Castle, PA. The remaining CDBG funding will be used for housing rehabilitation in the township. John Hines seconded and the motion carried unanimously.

PennDot Map – Cory Shaffer – Dight and Miller Roads are affected by the County line boundary change. Paul Dickey reported to the board that he and Randy Long, Road Foreman, met with Cory Shaffer, PennDOT, and discussed the issues on Miller Road. Dight Road is in decent shape.

Berkheimer – 2020 4th quarter – Covid-19 impact, no action was needed or taken on this issue.


Correspondence

Terry Doerr made a motion to adjourn the meeting at 3:25 p.m. John Hines seconded and the motion carried unanimously.




