

Slippery Rock Township Supervisors

Minutes for: 10/11/21

Chairman, Paul Dickey called the meeting to order at 8:00 p.m. In attendance were Supervisors John Hines and Terry Doerr along with Mark Lazzari, planning/zoning officer. Two public members attended in person.

John Hines made a motion to approve the September 27, 2021 minutes, approve and pay the bills, and approve the financial report. Terry Doerr seconded and the motion carried unanimously.

Open Comment(s)

1. **Ryan Hanchosky – SR Volunteer Fire & Rescue** was present and conveyed their issues with costs of fire vehicles, equipment, fuel and replacement of rescue tools. They are asking the Supervisors to consider adding a 2-mil fire tax which goes off the assessed home values calculated at approx. \$72,611.00. They have contacted surrounding communities to implement a 2-mil fire tax also. A discussion ensued with the outcome being the board will look at all information and discuss further and get back to SR Volunteer Fire & Rescue.
2. **Resident Mike McFeaters** addressed the board in regards to the Speed Limit along Miller Road located west of Arrowhead Drive to the bridge. The existing speed limit is 45 mph and wants to know what it would take to get this area's speed limit reduced. Paul believes our engineer did a study and it only warranted a change in the area from SR Borough Lines/short distance West of Arrowhead Drive. Paul suggestions, call the PA State Police to increase their patrol in that area due to speeding. The board asked the office to get information from our engineer per the speed study already conducted.
3. **Paul Dickey noted that Robb King**, SRU Interim Chief Communication and Public Affairs Officer emailed the board /SRU updates, which included a launch of a new vaccination campaign and introduction of Anthony Jones and his position with SRU. The board acknowledged this submission.

Plan(s) submitted for approval

1. **Lot Line Revision – SR Municipal Authority and Allegheny Mineral Corp.** Paul summarized this plan along with Mark addressing the board on behalf of the SRPC where the plan was approved earlier tonight at their meeting at 6:30 PM.

Terry Doerr made a motion to approve the Lot Line Revision for SR Municipal Authority and Allegheny Mineral Corp. as submitted. John Hines seconded and the motion carried unanimously. Paul Dickey elected to abstain since he is on the SR Municipal Authority Board.

2. **Neer Subdivision No 2.** Mark Lazzari summarized the SRPC review contingent on the Sewage Enforcement Officer to approve or concur with the non-building waiver and show the water and sewer on the residual tract of both homes plus show the full blowup of this tract on the plan. The board elected to table until all the contingent items are submitted.
3. **McDeavitt Subdivision.** Mark had no comment.

Zoning/Planning Report – Mark Lazzari

- ZHB last public hearing was cancelled due to zoom difficulties and dates currently being considered for another public hearing.

Unfinished Business

- **SRU - Stream Restoration and Dam Removal Project.** Mark reported he spoke with David Neill, engineer and he conveyed that a letter of response will be completed by Thursday, 10/14/2021.

Other Business

1. **Arrowhead Drive close** – trick-or-treat. Paul summarized the plan to close Arrowhead Drive and agree to Arrowhead resident manning both ends of the street as done last year for trick or treat 10/30/2021.

Paul Dickey made a motion to approve the closing of Arrowhead Drive during trick or treat on Oct. 30,2021. John Hines seconded and the motion carried unanimously.

2. **SR Park – 2022 budget.** A brief discussion ensued and the board would like to review this budget further and discuss at the next supervisors scheduled meeting.
3. **Suspending Zoom Participation.** Paul Dickey summarized conditions leading up to this decision.

Paul Dickey made a motion to suspend public zoom participation. John Hines seconded and the motion carried unanimously.

4. **2022 Budget** – review and comment. Paul noted about the new additions to the budget and will review further with Karen Connell.


Paul Dickey asked if there was any additional business and there was none.

Adjourn Meeting


Terry Doerr made a motion to adjourn at 8:34 p.m. John Hines seconded and the motion carried unanimously.




