

# Slippery Rock Township Supervisors

## Minutes for: February 27, 2023

Chairman, Paul Dickey called the meeting to order at 3:00 p.m. In attendance were Supervisors John Hines and Terry Doerr along with Mike Hnath, solicitor, and three members of the public.

*John Hines made a motion to approve the meeting minutes from February 13, 2023, approve and pay the bills and approve the financial report. Terry Doerr seconded and the motion carried unanimously.*

### Open Comment(s)

Scott Albert, SRU reported the following to the board:

1. Student Union construction should begin in April/May
2. Bids for the E-Sport lounge will be awarded in the next month
3. Softball field artificial turf will be done this summer
4. Design is completed for the Police-ROTC building
5. New President will begin in July, renovations have started on the President's residence.

**Sgt. Dan Sindlinger, PSP**, introduced himself to the board. He is the Patrol Unit Supervisor for the Butler Barracks.

### Engineer's Report

Paul Dickey reported the following to the board:

1. Paul explained to the board that the height, of the previously approved, salt shed will not allow a tractor-trailer to dump in the salt shed. Dave will investigate the cost to make the salt shed higher.

**John Hines made a motion to approve Dave Neill, engineer, to investigate the additional cost to raise the height of the salt shed. Terry Doerr seconded and the motion carried unanimously.**

**Butler County Park**, grant application, a short discussion ensued with the outcome being not to pursue this grant.

**Butler County** areas affected by the East Palestine, OH, train derailment, a short discussion ensued with the outcome to wait and see how Butler County Commissioners are responding to this issue.

**Wick Road** when driving Route 8 South the Wick Road entrance is hard to find, a short discussion ensued with the outcome being this is a state highway and PennDOT would have to evaluate the need.

**Forester Road Area** tires dumped in Wolf Creek reported by a resident, a short discussion ensued with the outcome being to have the road crew see if they can remove the tires and make Butler County aware of the graffiti on the bridge abutments.

**Signage request** for the Branchton Road and Harmony Road intersection. Request additional signs on Harmony Road stop signs, indicating this is a 2-way stop or cross traffic does not stop, a short discussion ensued with the outcome being for the road crew to install signs.

*Terry Doerr made a motion to approve the installation of additional signage at the Branchton Road and Harmony Road intersection indicating that this is a two-way stop, traffic on Branchton Road does not stop. John Hines seconded and the motion carried unanimously.*

**Signage request** for pedestrian crossings signs on Harmony Road when cresting the hill. A short discussion ensued with the outcome being to have the road crew install pedestrian crossing signs.

*Terry Doerr made a motion to approve the installation of pedestrian crossings signage on Harmony Road when cresting Harmony hill on both sides. John Hines seconded and the motion carried unanimously.*

**PENNDOT** spring outreach program on April 27, 2023. If anyone is interested in attending contact the office. No action was need or taken on this correspondence.


**BC Commissioners** fully executed ARPA Subrecipient agreement. No action was needed or taken on this correspondence.

*Terry Doerr made a motion to adjourn the meeting at 3:20 p.m. John Hines seconded and the motion carried unanimously.*


**Executive Session**
