• Mehlenbacher-Rassman Lot Line Revision - discussion ensued.

Jack Lawson made a motion to conditionally approve the Mehlenbacher-Rassman Lot Line Revision and forward to the Supervisors for consideration contingent upon the correction of the owner's name on map/parcel# 280-S13-A95-0000 to Slippery Rock Municipal Authority, the addition of a written statement verifying the easement with the property owners at 280-S13-A75-0000 and a written statement recognizing the responsibility of the owner to maintain the storm water pond located on this parcel. ## **ZONING/PLANNING REPORT – CLINTON BONETTI:**

- 1. Graff Surveying presented a subdivision plan (lot line revision) for Mehlenbacher Rassman.
  - a. It appears that a structure is placed on a sewer easement on Lot 33. (The property owner confirmed that the structure is a small shed on skidders, therefore able to be moved if necessary.)

- b. Two property owners are sharing a pond. Was the pond approved for the original stormwater management of the Applewood Meadows Plan? Where is the overflow or discharge located? Is there a maintenance agreement between the property owners?
- c. The Southernmost parcel in the Applewood Meadows Plan is listed incorrectly, 280-S13-A75 should be 280-S13-A95 owned by the Slippery Rock Municipal Authority for the pump station.
- 2. Clint had not received any updates for the Chapter 27 Amendment from the Solicitor.
