Meeting Minutes

April 14, 2025

The meeting of the Slippery Rock Township Board of Supervisors was held on April 14, 2025 at 8:00 p.m. in the Slippery Rock Township Building located at 155 Branchton Road, Slippery Rock, PA 16057.

CALL TO ORDER:

The meeting was called to order at 8:01 p.m. by Paul Dickey.

APPROVAL OF MINUTES:

John Hines made a motion to approve the minutes from the March 24, 2025 CDBG public hearing and March 24, 2025 regular meeting plus approve and pay the bills and approve the financial report. Jason Allen seconded and the motion carried unanimously.

PLANS:

SRU Intramural Fields Land Development – This plan was reviewed at the Planning Commission meeting 12/9/24. The Planning Commission granted conditional approval contingent on resubmission of the plan with the corrections made that were discussed and receipt of their NPDES permit. The revised plan and the NPDES permit were submitted to the office 4/4/25. David Neill, Township Engineer, reviewed the revised plan, and all comments from the Planning Commission and EADS have been addressed.

John Hines made a motion to approve the SRU Intramural Fields Land Development. Jason Allen seconded and the motion carried unanimously.

ENGINEER'S REPORT – DAVID NEILL:

Dave submitted report and Paul Dickey read report as follows:

Grants – PennDOT Multi Modal Grant – assist as needed.

McCandless Road Phase 2 – The County is running final environmental clearance and once received, we can finalize design and get ready for bidding.

SRU Intramural Fields Resurfacing – SRU received their NPDES permit and addressed all comments from the Planning Commission and EADS. We recommend final approval of the plans.

Kiester Road – Have contacted Peoples Gas multiple times starting last year. They responded last week that they were in the process of securing a GP permit for the stream crossing and had an environmental hit that they are trying to resolve. Unfortunately, they drag their feet on the plan and it seems like they are well behind schedule to have the work done in the near future. I will keep requesting updates from them on a weekly basis.

ZONING/PLANNING REPORT – CLINTON BONETTI: None

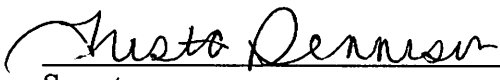
- BCTCC – Berkheimer contract expiration December 31, 2026 – no action taken
