CALL TO ORDER:

The meeting was called to order at 3:00 p.m. by Paul Dickey.

APPROVAL OF MINUTES:

John Hines made a motion to approve the minutes from the April 13, 2026 regular meeting plus approve and pay the bills and approve the financial report. Jason Allen seconded and the motion carried unanimously.

OPEN COMMENTS:

Scott Albert – Scott thanked Jason for installing the culvert at Slippery Rock University's property on Miller Road, and he said a check is being issued. Jason asked Scott to look at the field at the intersection of Harmony and Kiester Roads. When it rains there is dirt running off onto the sidewalk along Kiester Road which may also run onto the road. Scott will look at this.

PLANS: None

ENGINEER'S REPORT – DAVID NEILL:

David submitted an email that stated he is working with geologists to develop a cost estimate for the work on Hines Road. He also submitted an email regarding the Dirt and Gravel Road program. There is money available for road work and drainage, slope repairs, etc. A Road Master or Supervisor would need to attend a training session. This will be added to the next meeting agenda.

ZONING/PLANNING REPORT – RYAN COUNTRYMAN:

Ryan stated that comments have been received from the Solicitor as well as Butler County Planning Commission on the Zoning Ordinance Amendment regarding Recreational Campgrounds. A revised draft has been provided to the Supervisors. A public hearing date will be set and advertised.

UNFINISHED BUSINESS:

- **Saniga Road** – Paul, Jason, and David Neill met to discuss Saniga Road. They will get an estimate and discuss this project at the next meeting.

OTHER BUSINESS:

- **Rescind PennDOT agreement for Miller and Dight Roads approved at 11/24/2025 meeting** – A discussion ensued. The board would like to speak with Cory Shaffer from PennDOT. This has been tabled.
- **Rescind Resolution #25-8-2 – Highway Transfer Program** – Tabled
- **PennDOT Turnback Agreement #101020162 for Miller and Dight Roads** – Tabled
- **Resolution #26-4-1 – Highway Transfer Program** – Tabled
- **Building permits with public water and sewage** – A discussion ensued with the outcome being that before a building permit is issued for a property that will have public water and sewer, the property owner needs to contact Slippery Rock Municipal Authority. The Authority will provide the property owner with the fees that will be due and send verification to the Township that the property owner agrees to pay the fees. The property owner can wait until they tap-in to pay the fees. No Certificate of Occupancy will be issued until fees are paid.

ADDITIONAL OR FURTHER BUSINESS: Jason stated that the International truck has been repaired and is back.
